Structure of the PAGs:

"Principles and Guidelines to Strengthen the Social Dimension of Higher Education in the EHEA"

- PAGs is structured in the following way:
 - PAG contains a list of key principles necessary for the implementation of the social dimension in HE.
 - Each principle is accompanied by the guidelines that explain how to implement a principle.
- Definitions:
 - PRINCIPLES = high level statements that serve as a basis for the conceptualization of different policies for social dimension enhancement
 - GUIDELINES = instructions intended to advise policy makers on how the principles should be implemented in practice.


AG1 and the BFUG meeting in Helsinki (November 2019): conclusions

• **Starting point:** accepted definition for the social dimension – "[...] the student body entering, participating in and completing higher education at all levels should reflect the <u>diversity of our populations</u>."

2007 London + 2015 Yerevan + 2018 Paris Communique

- Social justice agenda: identifying vulnerable, disadvantaged and underrepresented groups of students
- Equality agenda
- **New elements:** social dimension encompasses creation of <u>inclusive</u> <u>environment</u> in higher education that fosters equity, diversity, and is responsive to the needs of local communities.
 - Public good agenda: social dimension <u>principles</u> should be <u>integrated into</u> the <u>core</u> higher education <u>mission and governance</u> (L&T, research, outreach)
 - Equity agenda


- ✓ <u>Forward-looking strategic</u> document

New cycle of the consultation on PAGs:

- Received extensive comments of 9 BFUG countries
- Received comments of the AG1 members
- Co-Chairs presented the PAGs at the BFUG Board meeting in Zagreb on February 7, 2020 – very well received!
- Co-Chairs presented the PAGs at the last AG meeting in Copenhagen on February 11, 2020 – very well received!



- ✓ Accepted almost all of the suggestions
- ✓ Created a new version of the PAG
- ✓ Defines 10 principles for social dimension in higher education for upcoming decade of the Bologna process 2020-2030

PAGs and the 2020 Rome Communique

- The Social Dimension > should remain at the core of the EHEA
- Stressing the importance of the implementation and monitoring of the PAGs

BFUG Work Plan 2020-2023

 - Defining **indicators and benchmarks for the principles** for the social dimension.
- Peer Support Groups should incorporate the topic of the social dimension:
 - Consider organizing the Thematic Country Reviews for the Social Dimension
- Organizing a conference on social dimension at the end of the next Bologna cycle:
 - Aim: discussing progress in the social dimension implementation in the EHEA
