2020 BPIR Report

- 6 chapters focusing on:
 - EHEA key data, degree structures, QA and recognition, social dimension, internationalisation, future challenges
- Combining:
 - « historical » narrative
 - statistical data (trends)
 - qualitative indicators (including scorecard)





WG1 meetings

4 meetings: July & November 2018, July 2019, February 2020:

guiding, planning and overseeing content development





Written checking

Future planning

- Continued drafting and integration of comments (March / April)
- Pre-final version of report for May BFUG

Task Force on promoting and protecting fundamental values:

- Task Force established by BFUG in Vienna, under auspices of WG1, to:
 - consider how fundamental values can be clearly understood across the EHEA
 - propose methodology for future reporting
 - recommend indicators of fundamental values, the evidence required to assess them, and the source for such evidence





Task Force meetings

- 3 meetings March, September 2019, January 2020
 Plus hearing with experts, May 2019
- 1st meeting agreed:
 - to focus on fundamental values as specified in Paris Communiqué
 - to prioritise establishing a common understanding of academic freedom (given short time until Rome)





Expert hearing (Berlin May 2019)

- focused on:
 - elements to include in a common understanding of academic freedom
 - potential sources of information for future reporting
- Text outlining common understanding of academic freedom developed collaboratively (experts and Task Force) after the hearing





Second Task Force meeting (October 2019)

Agreed the Task Force report, including proposal for:

- Short text in Communiqué
- reaffirming commitment to promoting and protecting fundamental values through dialogue,
- development of a framework for effective monitoring,
- adopting a common understanding of academic freedom supported by an explanatory statement to be annexed to Communiqué





Helsinki BFUG

- welcomed Task Force report
- no suggestions for amendments to the TF proposal,
- proposed that post Rome Conference work on values is pursued by a clearly mandated working group rather than a sub group of WG1
- 3rd Task Force meeting (January 2020)
 - mandated co chairs to re-submit the report to BFUG without changes,
 - discussed approach to future work

 (acknowledging BFUG's role to decide on future structure)
