  - o first PLA planned in September 2022 (BE) on 'Aligning the legal framework with the ESG'
  - second PLA March 2023 (RO) on 'Cross-border QA (CBQA) & QA of TNE'
  - o third PLA Sept 2023 (BE) on 'European Approach to the QA of Joint Programmes'

#### 3 thematic WPs:

- QA of Micro-credentials (ENQA) -> establishment WG April-May 2022, first meeting Sept 2022 (BE), guiding documents for HEIs and QAA, DEQAR
- QA of European Universities (BE) -> establishment WG April-May 2022, first meeting June (BE, online), analysis of legal obstacles, feasibility study, 2PLAs
- Digitalisation of QA processes (RO) -> start mapping April-May 2022, thematic workshop to discuss outcomes
