


SUPPORT THE TASK FORCE

Guidelines on Communication of the EHEA (practical and hands-on guidance and formats, examples, communication materials for national and cross-border activities)

- Scenarios for dissemination tools with EHEA visual identity, to be promoted at national/regional level and used for awareness-raising campaigns
- Proposal to enhance the attractivity of the EHEA website, by making the information more accessible
