Update from the European Students' Union (ESU)

New leadership:

The new Presidency of ESU started their mandate on 1 July for the period 2018/2019. Adam Gajek (Poland) is ESU's new president and Katrina Koppel (Estonia) and Robert Napier (Malta) are the Vice Presidents. ESU events:

The 36th European Students' Convention by European Students' Union (ESU) took place from 23 to 26 September 2018 in Vienna, Austria. The Convention focused on Public responsibility of higher education.

Project highlights:

Together, Moving Forward small grants programme

'Together, Moving Forward' is a small grants programme run by ESU aiming at building positive refugee-host interactions across Europe.

We kicked off this programme in the winter of 2016. Since then, we supported several valuable projects, shared views with resourceful activists and creative change-makers. We are also still confronted with little or uneven progress made by European governments and education systems, and perhaps an even more polarized public discourse regarding refugees and migrants.

The European Students' Union and Organising Bureau of European School Student Unions are running respectively Together, Moving Forward and Seeds for Integration, two small-grants programmes focusing on refugee and migrant education. In 2018 and 2019, we are cooperating and joining forces and have launched a Joint Call for initiatives developed jointly by the school and university students.

Work Plan Project

A mapping activity was carried out to see what topics are currently crucial for the student movement. It was decided that ESU will hold three seminars on democratisation, migration and mental health respectively. Each seminar will see between 15 and 20 participants coming from different countries across Europe.

Political statements:

ESU condemns the Suspension of Education Programmes for Refugees and Gender Studies in Hungary

Over the past month, the Hungarian government passed a new legislation attacking some higher education programmes. One of the bills condemns the field of Gender Studies and encourages a ban of the course in Hungarian Universities; the other bill aims to suspend any education programme for refugees and asylum-seekers in the country, among other dispositions penalising any support to immigration.

The European Students' Union (ESU) condemns both of these measures as they are attacking, in a very straightforward manner, academic freedom in the country, as well as many human rights conventions. As the government step by step deconstructs academic freedom, ESU also expressed its concern about the current state of democracy in Hungary and the consequences it has and will have on higher education.

ESU calls for better protocols and protection after sexual violence casts a shadow over EUSA games

The European Students' Union condemns sexual harassment of any kind, and stands for the rights of each individual to be free of infringements upon their person. We call for protection of rights for those who have suffered serious sexual violence at the EUSA games.

The University Games are organized every two years by the European University Sports Association (EUSA). Theses games gather thousands of student athletes from all around Europe. At the games currently being held in Coimbra (Portugal), female athletes have been victims of numerous acts of violence, from sexual harassment to an attempted rape. Others have also been the target of verbal and physical assault. The perpetrators, according to a Press Release issued by the Finnish Student Sports Federation (Opiskelijoiden Liikuntaliitto ry- OLL) on July 24th are identified as being male athletes, as well as an older male coach.
