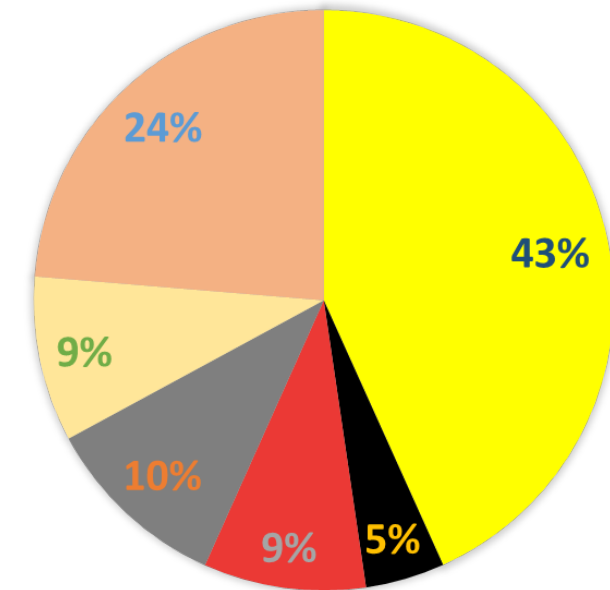
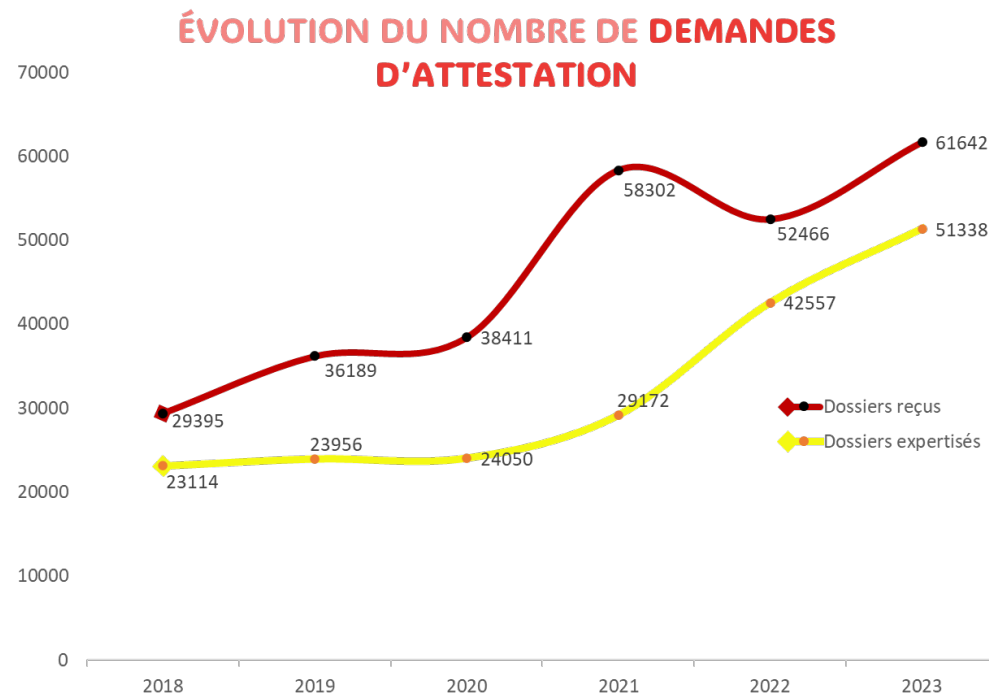

The French report card : year 2023

- 61 542 requests received
- 3 071 from Ukraine
- 51 338 requests evaluated
- 50 404 certificates established

Digital

- New platform for the deposit of recognition certificates to be opened to the public on June 3, 2024 (after two years of internal development)
- Research on welcoming the public via AI (Cybèle bot...)

Automatic recognition

- Active participation in the AR25 project (NUFFIC)
- Active participation in the MAREN project (CIMEA)
- Grand départ « Tour de France of AR » (FEI) : explaining and promoting AR to HEIs nationwide in France through a series of round tables academy by academy
- Tight concertation with MESR on AR & BFUG and annual national webinar (09/03/2023, 26/03/2024, March 2025 – precise date to be confirmed)

French Initiatives in Recognition of refugees

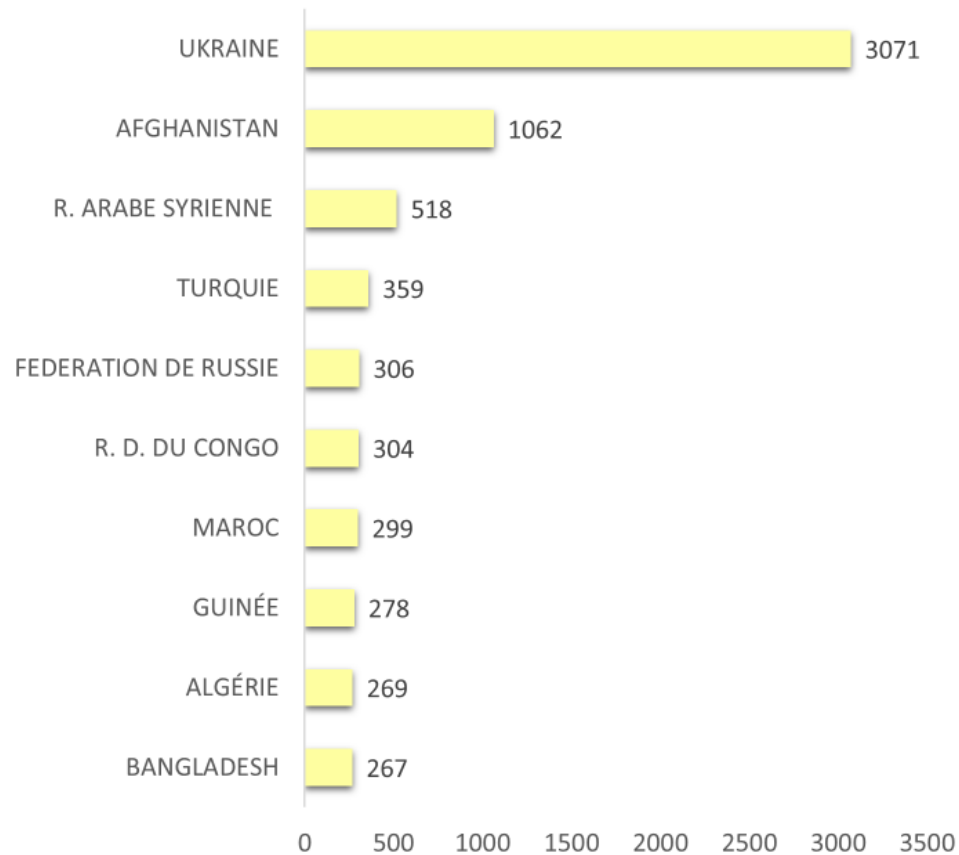
- Priority treatment for refugees (BPT and assimilated) : fast track treatment of comparability certificates & procedure free charge
- Participation in several French national networks and initiatives in the field of integration of refugees (DIAIR, refugees.info, Réseau MEnS....)
- DG Reform /EU Commission, OCDE, DIAN (French ministry of Interior affaires) on BPT from Ukraine : recommandations to improve evaluation, recognition, and validation of qualifications in France
- EQPR session with the Council of Europe in Lyon 17-21 June 2024 (120 candidates)
- UQP : three sessions with UNESCO in Zambia, Uganda and Kenya (April-June 2024)
- Information, promotion, dissemination & cooperation

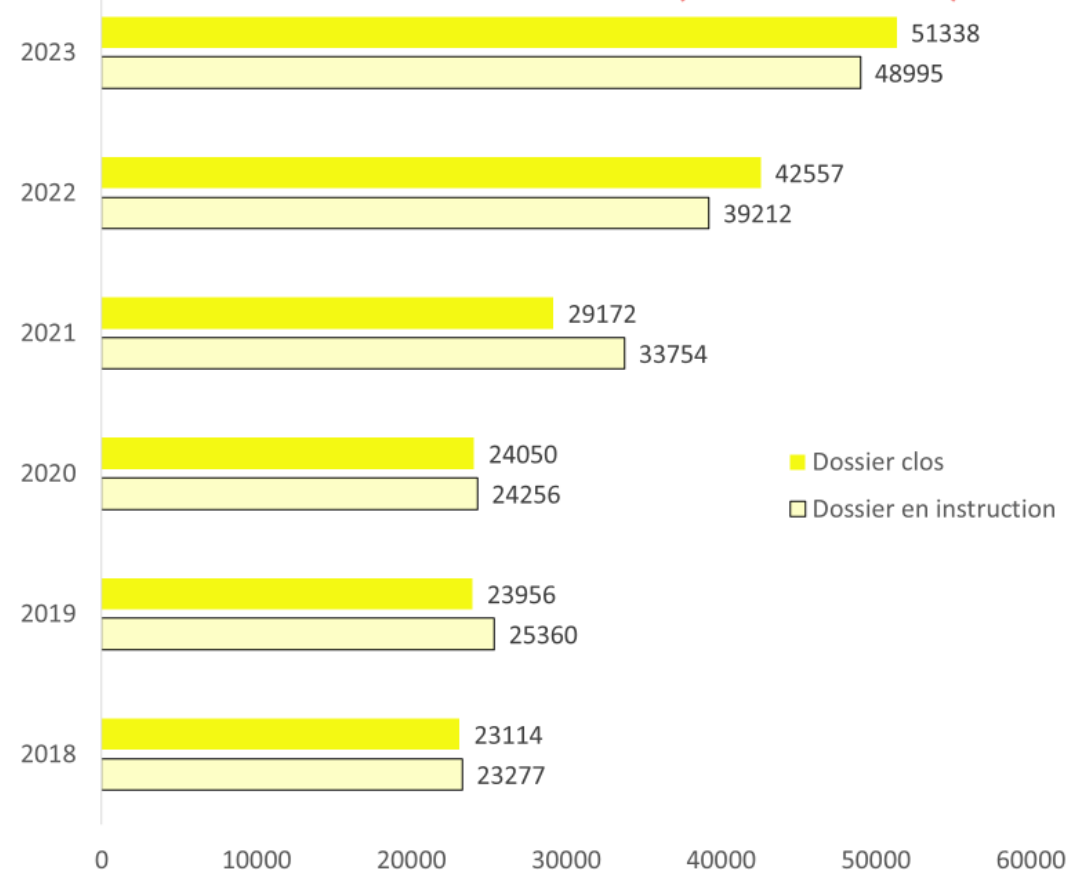

Challenges in the light of recognition of refugees

- New skills, new needs for the labor market – new tasks for ENIC NARICs :
more research work on integration procedures, recognition of medical and paramedical diplomas, childcare qualifications etc...
How can and must ENIC NARIC Centres adapt (HR...) ?
- Integration of refugees within Europe (Ukraine...) and from other continents towards Europe such as Afghanistan, Middle East, African countries :
opportunities and limits of EQPR – an HR-intense & costly process ;
a water drop on a hot stone ?
- Recognition of refugees within Africa and the Middle East : the UQP - UNESCO Qualifications Passport :
a new opportunity to develop recognition, evaluation and mutual understanding especially between non-European countries, in transforming positive aspects building of the EQPR experience in Europe
