On 20-22 February, BFUG Secretariat circulates the candidatures to the BFUG members (min. two weeks prior to the next BFUG meeting). EHEA members not attending the next BFUG meeting submit their votes in a sealed envelope to the BFUG Secretariat.

In the April BFUG meeting, BFUG Working Structures will present ToRs for the next period (2024-2027).

Finalisation of the selection procedure for the next host(s) of the next Ministerial Conference and BFUG Secretariat. The host(s) will be finally endorsed by the EHEA Ministers responsible for higher education at the 2024 Tirana Ministerial Conference.

Approval of final reports for the BFUG Working Structures.

Candidatures Received

A letter of expression of interest was received on <u>13 December 2023</u> from the Ministry of Education of Moldova, expressing the interest in co-organizing with the Romania the next Ministerial Conference and the Global Policy Forum in Iaşi (RO) and Chişinău (MD), as well as hosting the Bologna Follow-up Group Secretariat for the period 2024-2027.

- Deadline for the letter of interest to be circulated among the BFUG on February 22, 2024.
- Considering it is after the 1st BFUG, would the Board consider the change of the date and when?
- If prior will there be any item on the agenda for the presentation of the candidacy for the BFUG in February?
 - If so both RO and MD should be notified in time to have the presentation forwarded to the BFUG
 Secretariat two weeks before the BFUG meeting as the deadline for all the Working structures.
