Draft Terms of Reference

- **Composition:** to keep the existing structure (members and consultative BFUG members and co-chairs of each of the TPGs; WG Monitoring representative as an observer);
- **Purpose and tasks:** coordination, monitoring of the peer support activities, reporting to the BFUG
- **Continuity:** The activities should build upon the outcomes and recommendations of the work of the TPGs presented in the BICG Report

- Invitation to express the interest – the BICG survey
