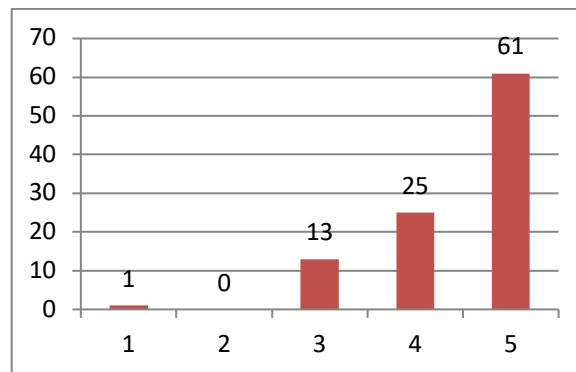
## EHEA Ministerial Conference Paris 2018 Satisfaction survey

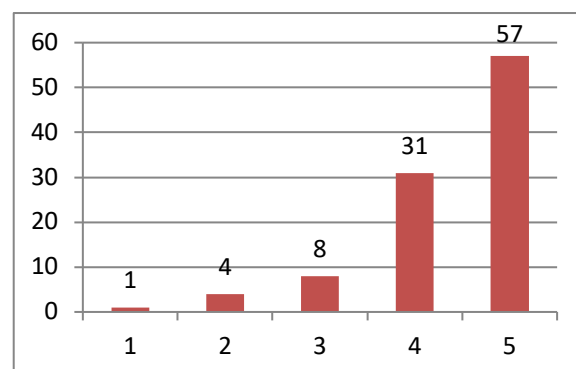

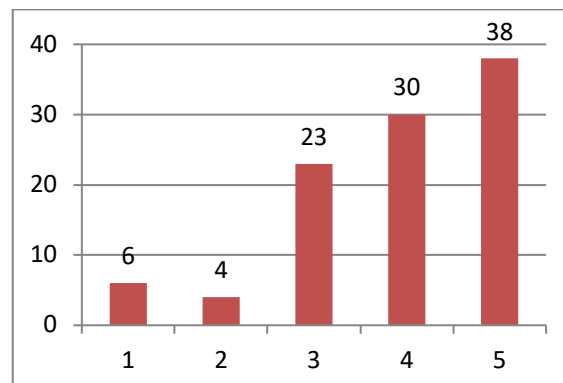

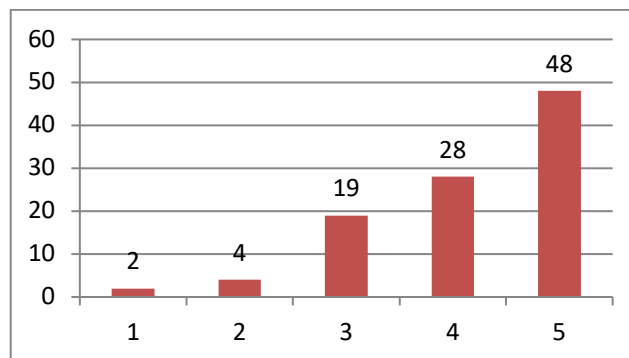

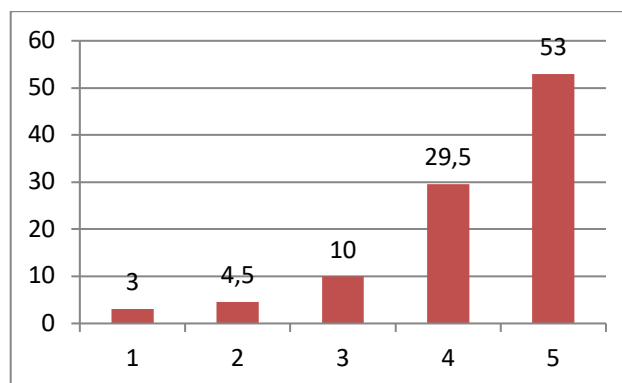

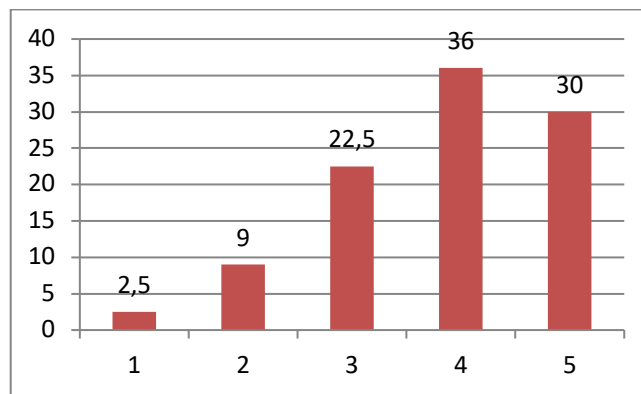

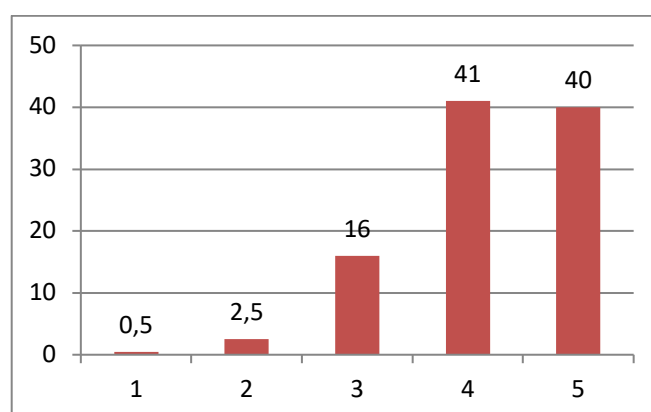
