INTRODUCTION

- **Objective:** facilitate the exchange of best practices, foster transnational dialogue and promote peer learning and mutual understanding among EHEA countries, in the field of quality assurance.
- Each mobility is designed to contribute both to the **professional development of participating peers**, and also, to **the advancement of quality assurance implementation at both national and institutional levels.**

- Funding up to a maximum of **€800 per participant**

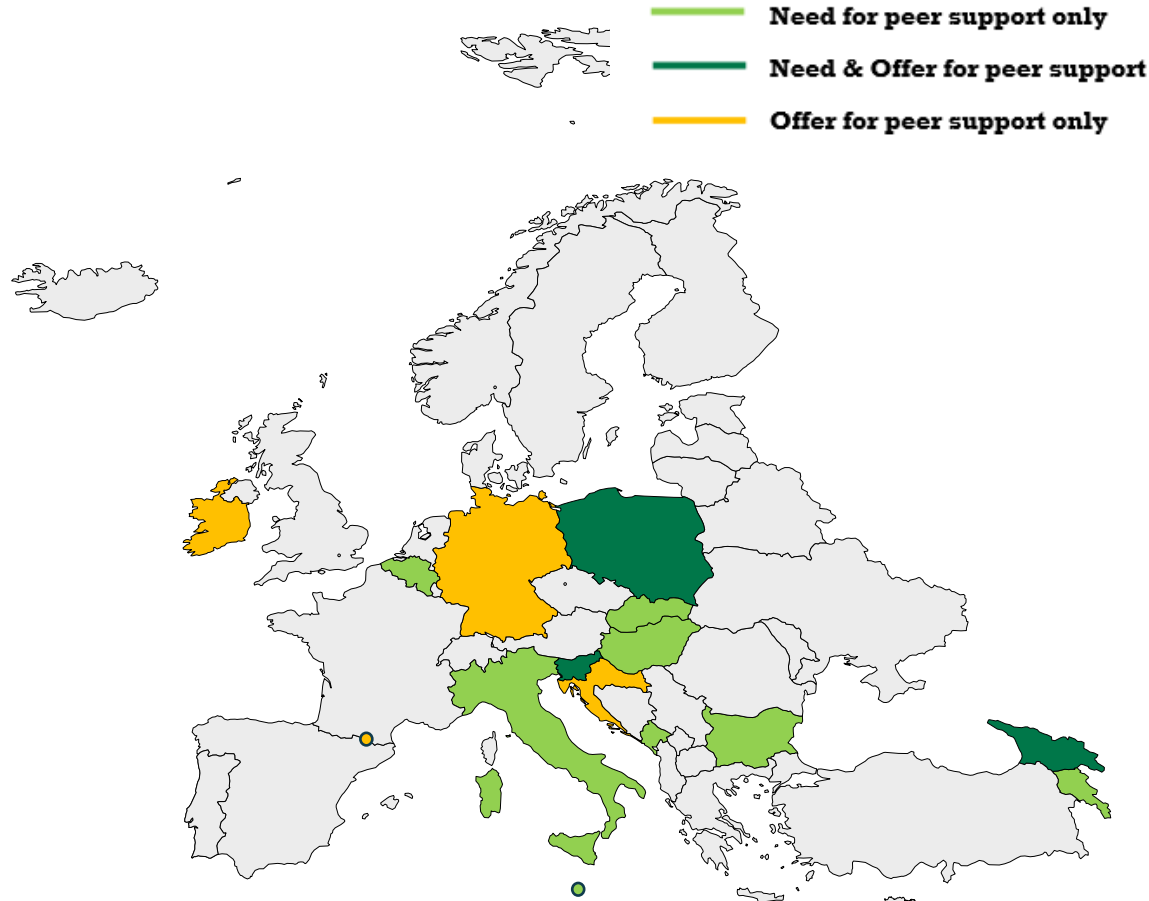




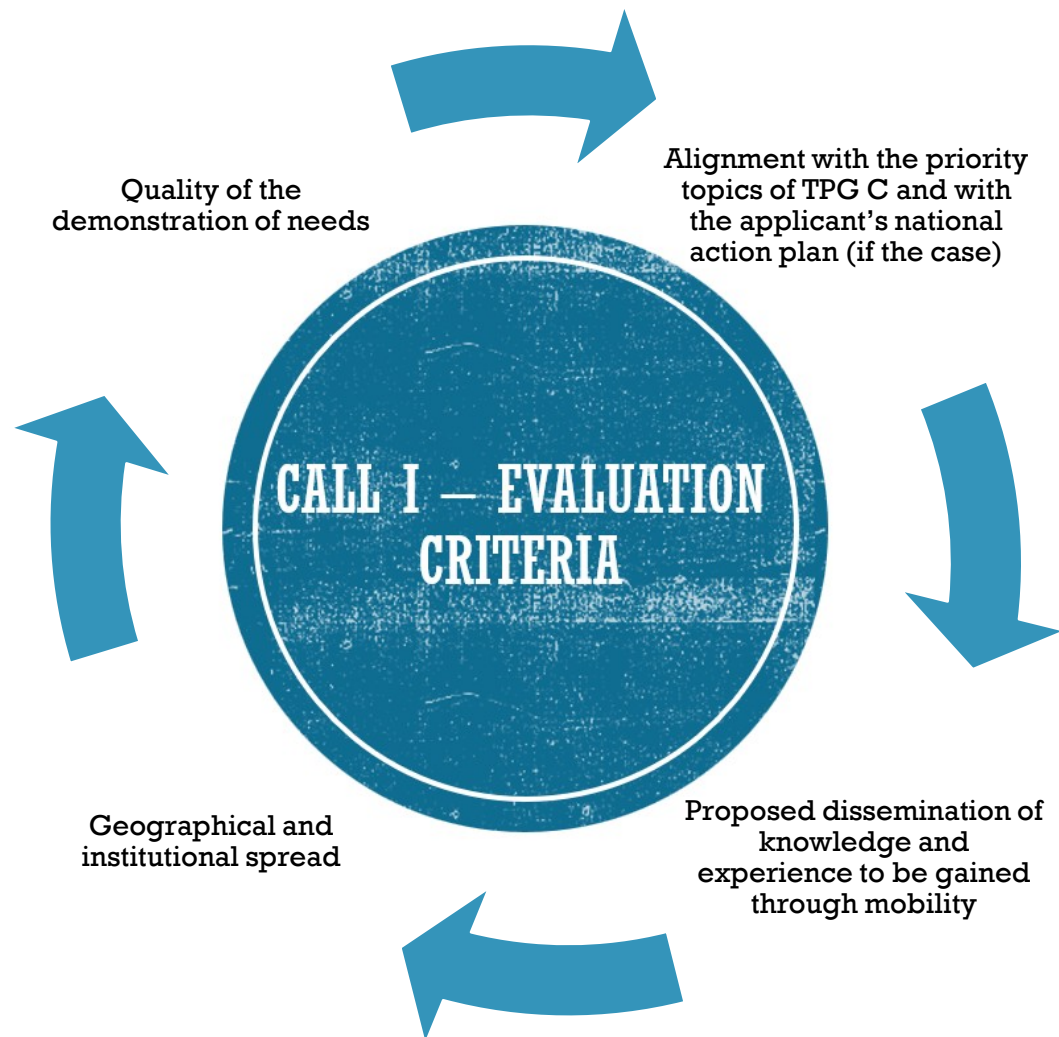
Timetable:

- Announcement of selection results: 27 February 2026
- Study visits: April – July 2026
- Submission of staff mobility reports: 1 month after the end of study visits
- Evaluation of study visits reports: September – October 2026

CALL I – EVALUATION RESULTS

10 applications accepted

- **17 mobile staff members: 16 from QA Agencies and 1 from Ministry**
- **1 application to provide more information/confirm host availability**
- **1 application deferred to call II due to a mismatch in the mobility period between the sending and receiving organisations**

1 application rejected

- **the need for peer support was not sufficiently articulated at institutional level and did not demonstrate alignment with the national action plan**

- **Fit-for-purpose implementation of ESGs**
- **Innovative External QA approaches**
- **European Approach for Quality Assurance of Joint Programmes**
- **Cross-Border Quality Assurance (CBQA)**
