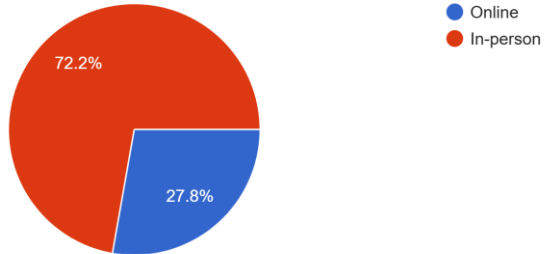

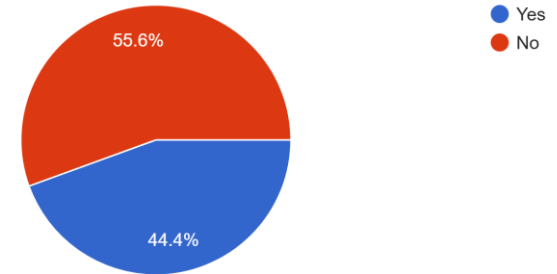

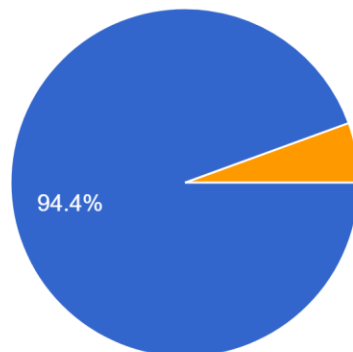


Feedback form results

- Information was neither sufficiently detailed nor transmitted early enough

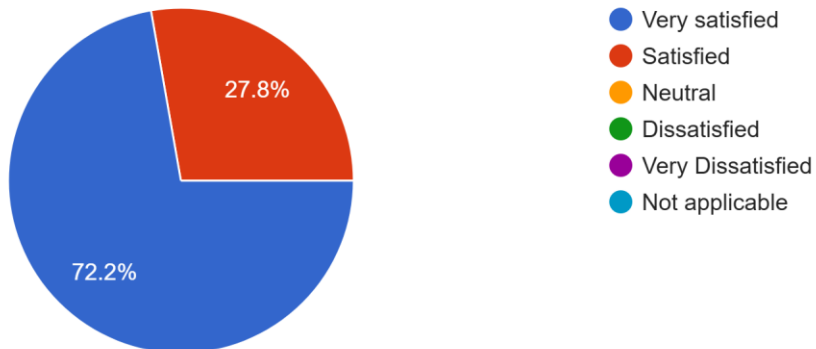

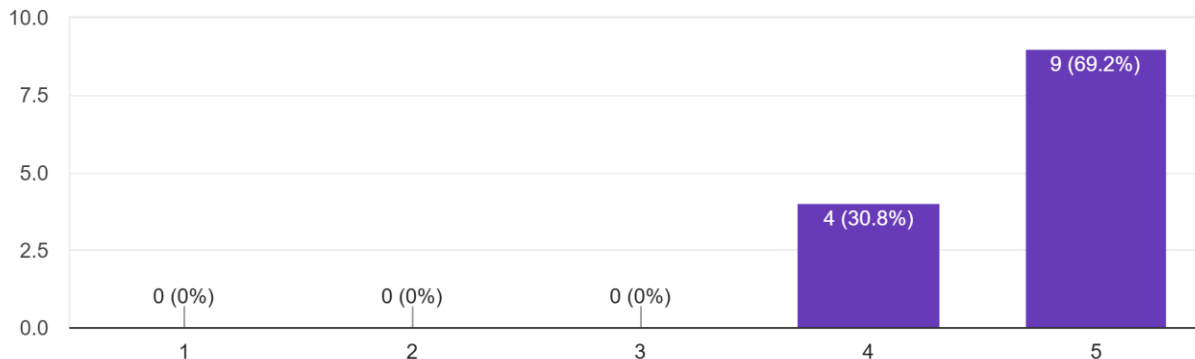

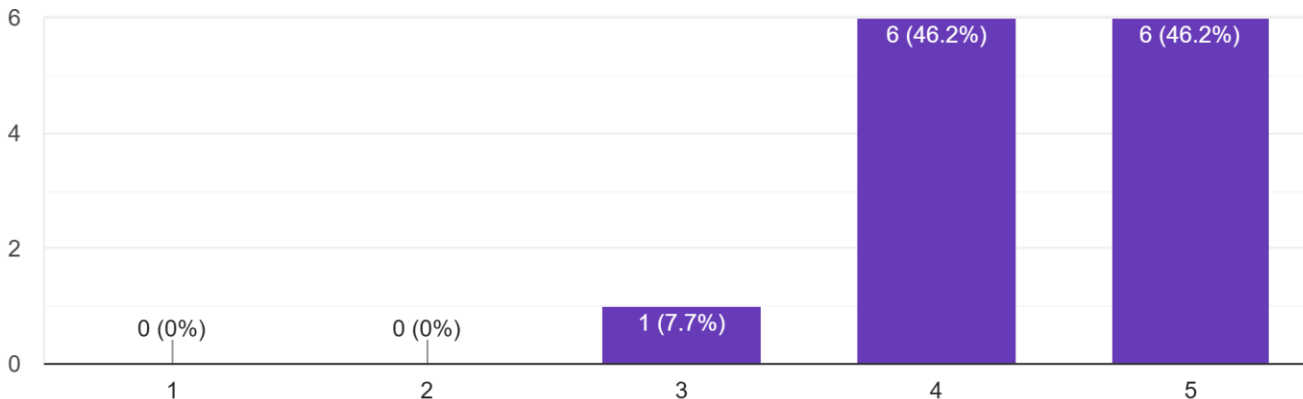

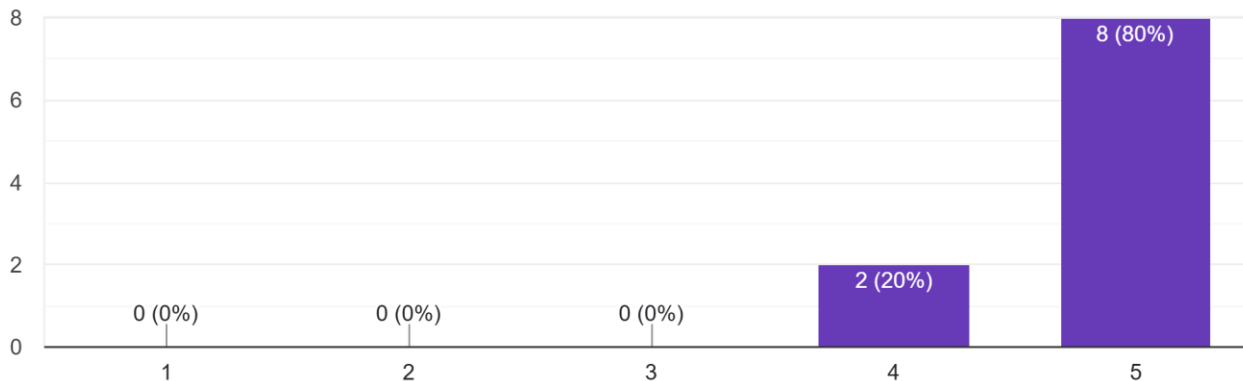

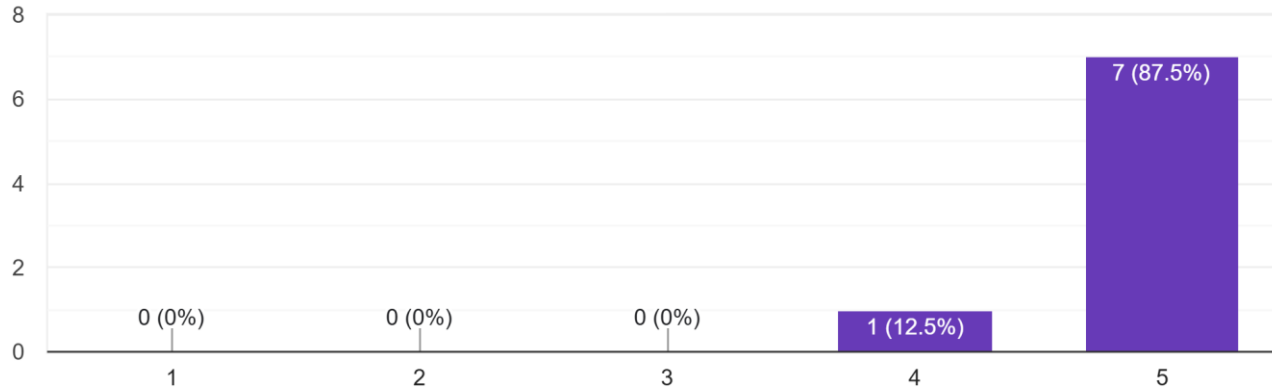

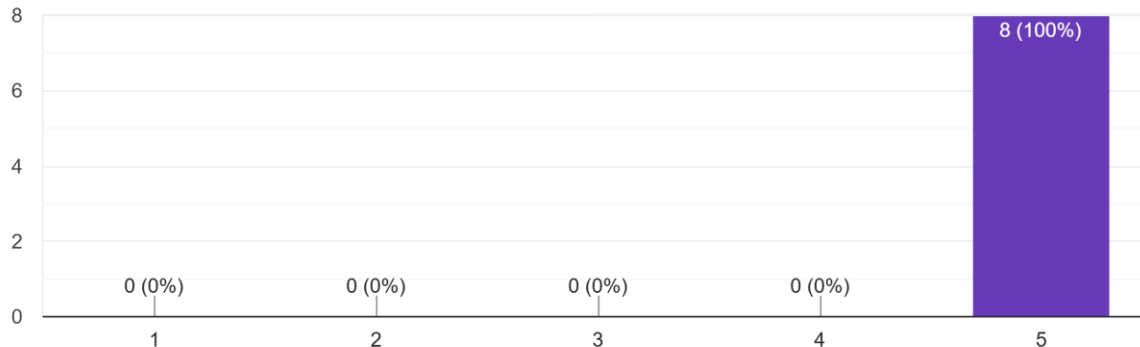

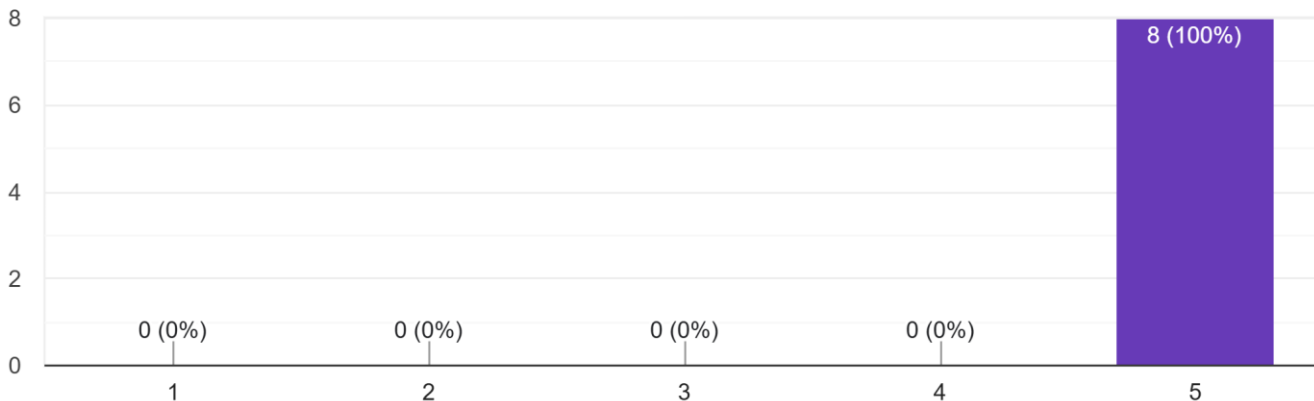

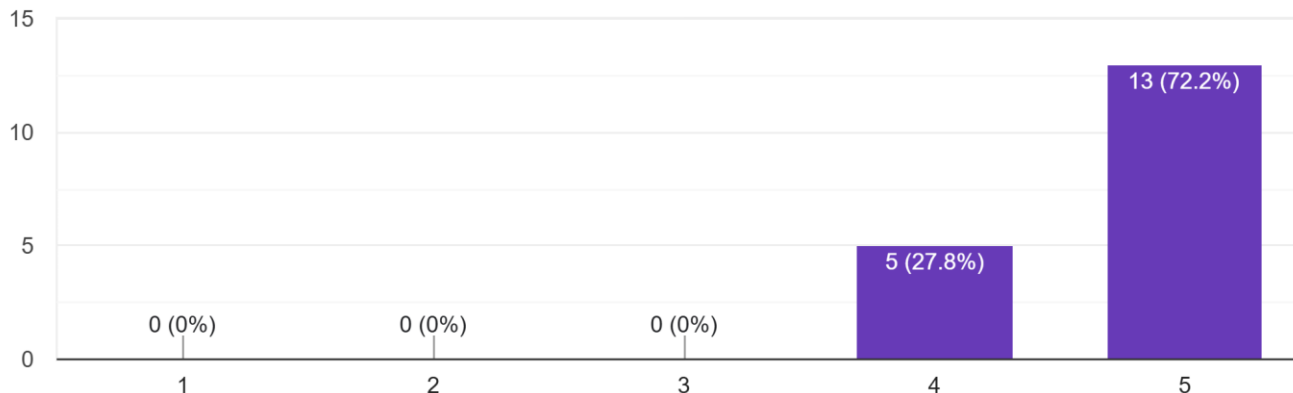

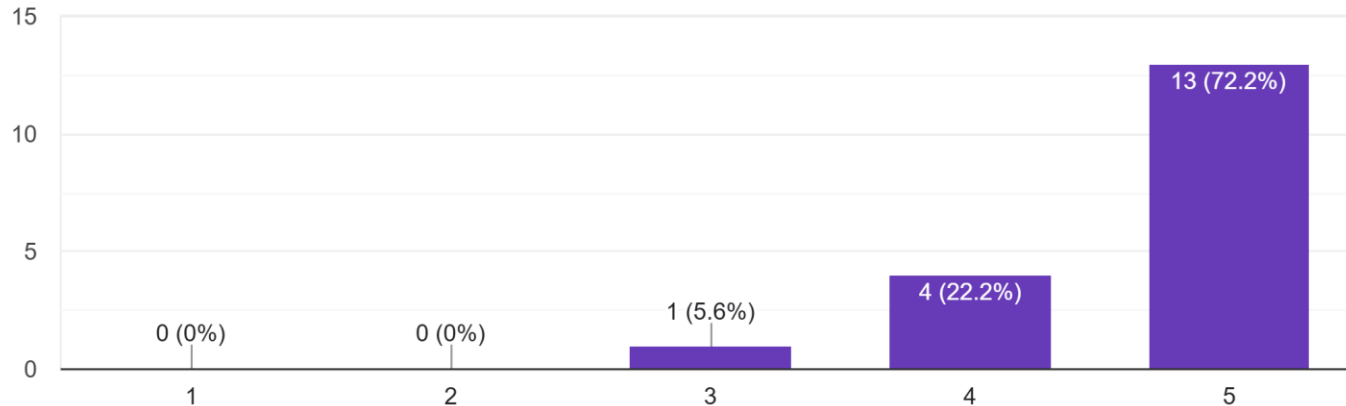

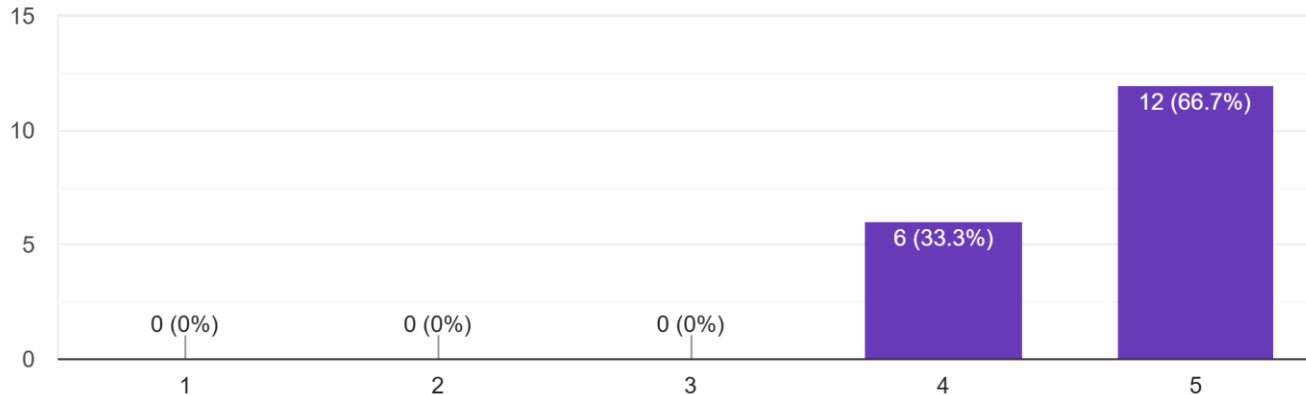

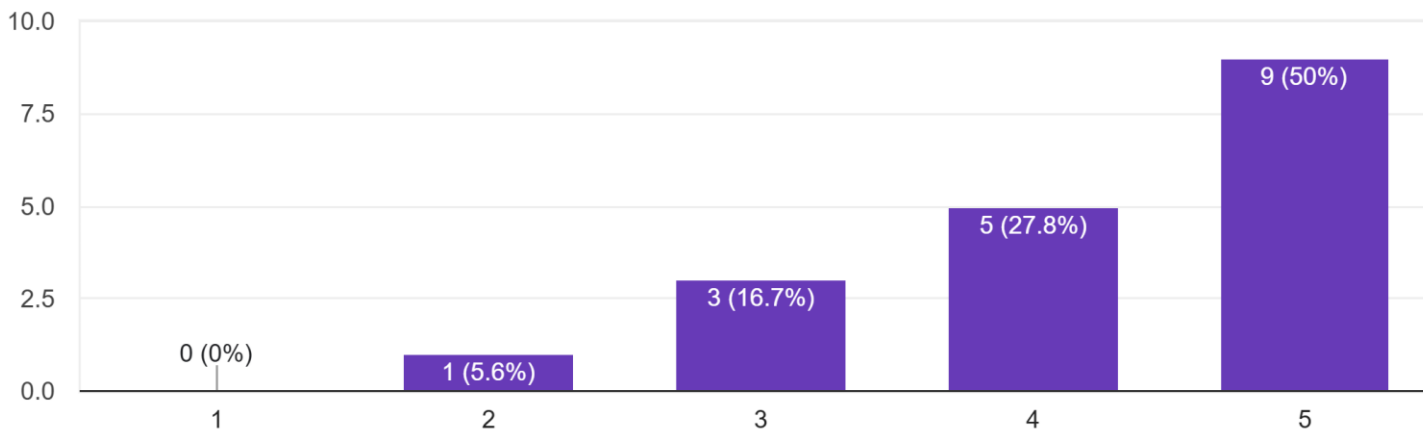

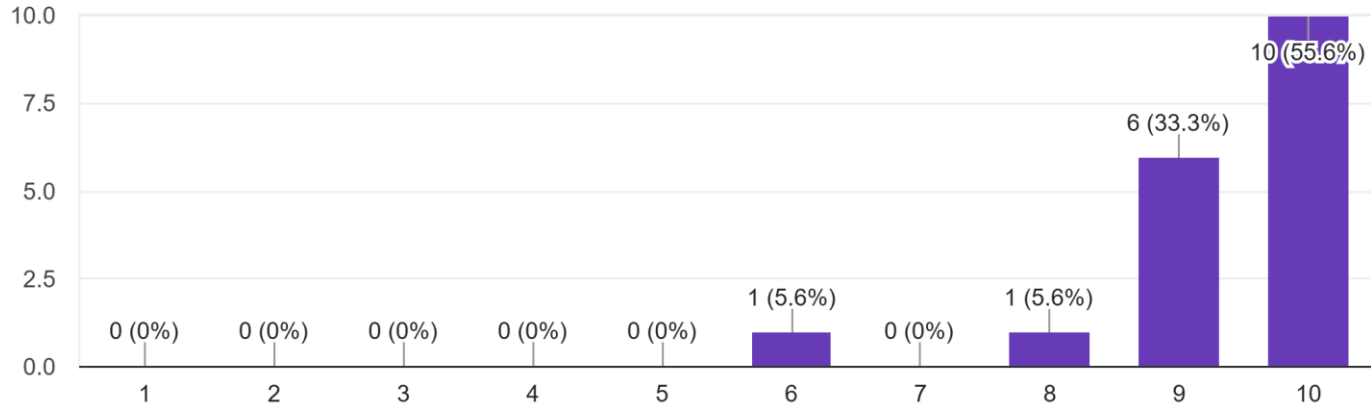
